Resolution of the meeting:

*The Anti-Ragging Committee, headed by the Officer-in-Charge, shall ensure an overall disciplined and Ragging-free environment in the College Campus. Ragging in any form is strictly prohibited and is a punishable offence. Anti-Ragging rules following UGC guidelines are to be maintained by the students.

* At the beginning of the academic year both the students and their guardians will be made aware of the ragging related rules and regulations by the College authority and they have to submit an Anti-ragging declaration form.

*Any act resulting in mental/physical/sexual abuse, verbal abuse, indecent behavior, criminal intimidation/ wrongful restraint/ undermining human dignity/ financial exploitation/ extortion, use of force can be treated as Ragging as per UGC norms.

*The Anti-Ragging Committee, as constituted by the College, shall examine any complaints of Anti-Ragging and come out with recommendations based on the nature of the incident. The convener shall regulate the affairs along with the members.

*A student found guilty by the Committee will attract any of the following punishments, as imposed by the Anti-Ragging Committee:

- Cancellation of admission.
- Suspension from attending classes.
- Withholding/withdrawing Scholarship and other benefits.
- Debarring from appearing in any examination or other evaluation process.
- Withholding results.
- Debarring from representing the institution in any academic, cultural or sports activities.
- In cases where the persons committing or abetting the act of ragging are not identified, the Institute shall resort to collective punishment.
- An appeal against any of the orders of punishment enumerated herein shall lie to the Officer-in-Charge of the Institute.
