1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Affiliated to Vidyasagar University, Government General Degree College at Kharagpur-II, located at the Village Ambigeria, Block Kharagpur-II, District: Paschim Medinipur, is the only government college in the block, and is under the Higher Education Department of the Government of West Bengal since its inception from the academic session 2015-16. The college is well connected by rail from Howrah station via Panskura junction and by road from Kolkata via Kolaghat having Madpur as the nearest railway station and Madpur Ghat as the nearest Bus stoppage on the National Highway-6. The prime objective of the co-educational academic institution is to provide equal opportunities to the rural students of the surrounding region to acquire higher education along with academic knowledge and moral values and also to provide a platform to nourish and explore the special abilities, talents and bright career prospects of the students irrespective of their gender, background, caste and creed. In June 2015, the college began its journey in a concrete building under construction, the college today has a three-storied building with 17 class rooms, well equipped laboratories, a play ground, a library and dedicated teaching and non teaching staff who work in coordinated manner in harmony with the sole objective of catering quality education to the students. The college has received recognition under section 2f by UGC in 2017-2018, has 11 departments currently offering undergraduate B.A. Honours and General courses in English, Bengali, History, Political Science, Philosophy and undergraduate B.Sc Honours and General courses in Chemistry, Physiology, Botany and Zoology; Undergraduate B.Sc. General courses are also offered in Mathematics and Physics. A large portion of the students of the college, come from the remotest rural areas of the district and beyond from low income families and agricultural background, and are taken care of by the college to receive the available scholarships and the Government financial schemes meant for the students in order to assure their uninterrupted continuation and completion of higher education at the college. Thus, the college being the only Government college in the region, serves as a powerhouse of opportunities to all aspirants of higher education in the surrounding rural region.

Vision

The vision of the institution is to disseminate quality education and knowledge to the young souls which is necessary to help them to grow up to be wise, responsible, sincere, empathetic, confident, brave, well behaved, strong and dutiful citizens of the country. The institution looks ahead to ignite scientific temper and impart the concept of gender equity in every student and to assure complete development of the students equipped with education, knowledge, morals, wisdom, intellect, basic life skills and values making them capable of facing the challenges of life with precision and a delightful heart.

1.2 Strength, Weakness, Opportunity and Challenges(SWOC)

Institutional Strength

1. Government General Degree College at Kharagpur-II is the only college in this particular rural locality. This is a backward area with high population of economically underdeveloped villagers. So, this college enables to serve and empower the marginalized section of the society.

2. The infrastructure facilities of the institution is in developing stage.

3. This institution is blessed with highly committed and efficient faculties and staff.

- 4. The students perform consistent academic results.
- 5. The institution indulges in resourceful community engagement and outreach activities
- 6. The college provides strong and sound mentoring and counselling system to the students.
- 7. This higher education institution has signed MOU-s with various other institutions for enrichment.

8. The college provides various skill-based programmes.

9. Scholarships like Kanyashree Prakalpa, SVMCM, Oasis Scholarships for SC, ST and OBC students, Aikyashree scholarships for the minority students are provided to reduce dropouts.

Institutional Weakness

- 1. Being a new college, further infrastructural strengthening is required.
- 2. Being a fully government institution, we need to depend on PWD for any civil and electrical work even if it is of utmost importance.
- 3. Due to lack of fund, seminars/ workshops/certificate course are organised with difficulty .
- 4. The library lacks adequate books due to constraint of fund.
- 5. Most of the students are local, so a cosmopolitan learning atmosphere is lacking.
- 6. Being a government college financial resources are obtained only from Government fund.
- 7. More alumni participation and contribution are required for development.
- 8. We need to undertake more collaborative activities, interdisciplinary research etc. within the institute as well as with other institutes of eminence, industry houses etc.

Institutional Opportunity

- 1. This institution gets the opportunity to serve and empower the marginalized section of the community.
- 2. Proper implementation of LMS (Learning Management System) is maintained.
- 3. There is initiation of more skill-based programmes, and extension activities to the society.
- 4. There is scope for funded research in agriculture and environment
- 5. The institution organizes various outreach programmes like Dengue awareness, Health camp etc.
- 6. A scope of strengthening e-content resources as a part of virtual learning in the curriculum
- 7. The college has the opportunity in bringing more first-generation learners to the mainstream of education.

Institutional Challenge

- 1. The college faces acute shortage of classrooms and to take classes simultaneously is a challenge.
- 2. The authority does not have the power to recruit faculties or staff in emergency also, without Government Order.
- 3. A major portion of students are rural with average and below-average learning abilities.
- 4. It is hard for them to meet the global standards.
- 5. Obtaining funds, especially during and immediately after the current pandemic situation is a challenge.
- 6. Getting placements for students in this restricted scope is felt.
- 7. There is a tendency of early marriage among the girl students and dropout due to various reasons, mostly economic.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

The Government General Degree College is affiliated to Vidyasagar University since 2015 and it follows the academic calendar laid down by the University for UG courses. Earlier the UG courses were conducted as per the 3 Tier Pattern and later on as per the Choice Based Credit System. In the current session the new system for UG courses have been introduced as per the CCFUP-NEP. A proper full proof method of teaching is followed that comprises equal distribution of syllabus, regular interactions with the students, a compact teaching plan and interactive teaching methodology. Special attention is provided to the slow learners. Regular assessments of the progress of the students are made though class tests. Some departments of the college also organize some Addon courses for the benefits of the students on varied interesting topics. The NSS unit of the college holds awareness programmes on various topics of scientific, environmental and social issues. Also, field work, excursions and project works are conducted by different departments. Some departments held seminars to provide exposure to the students to the current aspects of science and technology and to train the students about presenting posters and talks. Many departments also publish their wall magazine regularly. The college held sports events for the students.

Teaching-learning and Evaluation

A transparent admission process for UG programmes involves clear criteria, publicly available information and a fair evaluation process. Applicants are informed about requirements, deadlines and selection procedures. Decisions are based on merit. This ensures accountability, builds trust and enables informed decision-making for applicants.

An effective teaching -learning process in College is a dynamic and interactive experience. Clear goals and objectives are established and engaging lectures encourage active learning and participation. Regular assessment help students stay on track, while encouragement of critical thinking and inquiry fosters deeper understanding. Continuous evaluation and improvement ensure that the teaching -learning process remains effective and relevant. This process empowers students to take ownership of their learning, develop new skills and knowledge and achieve academic success. By adopting effective teaching practices, educators can inspire students to become lifelong learners and prepare them for future careers. Technology and resources are leveraged to enhance learning and a supportive and inclusive environment promotes students encouragement and motivation.

Evaluation is a systematic process that assesses student learning, teaching effectiveness and program quality. It involves setting standards and providing feedback to improve student outcomes and teaching practices. Evaluation ensures accountability, informs decision-making and drives continuous improvement, ultimately enhancing the teaching -learning process.

Research, Innovations and Extension

Research and innovations are two interconnected domains that are intricately associated with the progression of human education. Therefore, to enshrine the importance and need of research and innovations in the premises of higher education, the Institution takes pride in preparing the environment suitable for performing research activities and takes the following initiatives.

Organizing a large number of offline and online seminars in a regular basis initiating from the pandemic period in order to engage the focus of students towards interacting sessions besides their syllabus of curriculum to enrich and diversify their learning processes. Moreover, the Institution has also published some Wall Magazines.

The Institution highly encourages the direct involvement of the faculties of all the Departments towards the realm of research. As a consequence, the Institution has a few faculties currently pursuing Ph.D degree. 16 faculties already having Ph.D degree, 03 faculties having Post- Doctoral experiences. Alongside, the Institution has also published large number of papers in UGC Care Listed Journals and in Peer- reviewed Journals. Besides, the faculties have contributed chapters in the books.

The NSS has taken the remarkable initiative to adapt the local village. and organized Plantation programme inside and outside the Campus.

The NSS has organized medical campus in order to provide the local villagers the facility of health check up.

Infrastructure and Learning Resources

Infrastructure plays an important role in determining the academic as well as overall performance of learners in any educational institution. This newly established college tries its best to invest in infrastructural facilities to create a robust atmosphere for overall progress of students. The college provides the following infrastructure & learning resources for students:

The college campus is well connected from all places. It is situated at 15 minutes walking distance from Madpur Railway station and 30 minutes from NH 6 (Madpur Ghat Bus Stop). The college i spreads across 5.87 acre of land. The academic cum administrative building has Principal's Office, class rooms, laboratories, library, Guest Room, Seminar Hall, conference hall, exam cell, Gymnasium.

The college has 17 well ventilated classrooms and departmental laboratories of Botany, Chemistry, Mathematics, Physics, Physiology and Zoology are equipped with more or less all the scientific equipment and chemicals.

There are 30 computers, 5 projectors, 8 scanners, 14 printers and internet connection of 300mbps speed installed. Two Smart Classrooms help in delivery of curriculum.

1.112 acre playground for outdoor sport events, one sport room and one gymnasium with basic fitness equipment are constructed in the college. A well equipped library possessing books in both English and Bengali language is found here.

The institution also has NSS unit, Girls Common Room, drinking water facility, facilities for specially abled students Sanitary napkin destroyer for faculty. The institution ensures that the available infrastructural facilities are optimally utilized.

Student Support and Progression

This criterion is about the students, who form the main pillar of the institution. Here, meaningful learning is ensured by the teachers to their students. The environment of the college is very much safe and educative, which contributes to the holistic development of our students. The learners receive scholarships, e.g Aikyashree (for minority students), Swam Vivekananda merit-cum-means, Oasis (for SC, ST, OBC and minority students), Sitaram Jindal etc. The college has made necessary arrangements for regular counselling of students, along with career counselling workshops and a feedback system. The institution maintains a very strong mechanism for students to address any grievances through Grievance Redressal Cell, where prompt action is taken to address any problem. Needy students receive special guidance and financial help from the faculty. Besides, regular parent-teacher meetings are conducted by the departments to make the students and their parents aware of the progress of the students. Here, students learn soft skills, language and communication skills including basic computer. Special emphasis is given on the students' physical and mental health, and on their health and hygiene. Our students actively participate in cultural programme, sports events, activities for environmental awareness and also in community reach-out programme. The institution has an inclusive campus - free from ragging or any form of gender discrimination.

Governance, Leadership and Management

The vision of the Institution is to provide value-based higher education to all. This Institution focuses at the holistic development of the students in order to help them gain in-depth knowledge and academic expertise. The mission of the Institution is to enable them to meet the challenges in their chosen field in future. Our college, being a government college, is administered by the Higher Education Department. The institution emphasizes the issues like students' welfare, faculty development and Internal Quality Assurance Cell. The Officer-In-Charge plays the key role in monitoring overall academic - administrative, financial and all the other activities after consulting the Teachers' Council and IQAC. The Teachers' Council has several academic and administrative sub-committees to execute the plans and programmes. The institution follows e-governance systems like HRMS, WBIFMS and maintains an effective welfare system through the WBHS. For the students, there are online admission system and various scholarships. Tteachers submit their online SAR every year. The Institution strictly follows e-tender system for purchasing goods and conducts internal/external audits regularly. Faculty members upgrade themselves through Faculty Development Programmes. IQAC plays a significant role in framing and implementing the academic and administrative activities, such as assisting the Officer-In-Charge in matters relating to CAS, in organizing Add-on/Ccertificates courses. Maintaining and enhancing quality of an institution is a continuous process, which is served by IQAC. The institution has successfully participated in NIRF - 2023.

Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:

The new syllabus under The 'National Education Policy 2020' gives ample opportunity to the students to study the combination of subjects of their choice and interest. This not only helps to quench the thirst

	of learning things of the subjects of one's personal interest and choice but also provides a vast arena of knowledge to the learner. The college provides freedom to the students to elect subjects of their choice as combination in their curriculum. This also helps to develop an all round knowledge of the students that will definitely strengthen the concepts and will helps him in his higher education and further. Thus students get the chance to gain interdisciplinary knowledge. Also, under the environmental studies, that is compulsory for all students to undertake, the students from different discipline get the opportunity to acquire multidisciplinary knowledge that is covered under the syllabus of environmental studies. The college allows teachers from specialized background to held classes for specific multidisciplinary topics of the environmental studies paper. This also provides a scope for the students to learn directly from teachers of different disciplines. A big number of students from all departments of science and humanities of the college are active volunteers of the NSS Unit of the college and they participate together from in different types of multidisciplinary programmes covering social awareness, environment awareness and sensitization about various social and health issue etc., organized by the NSS unit. Also active interdepartmental collaborative research in science and technology within limited resources of the institute involves students and this leads to interdepartmental collaborative publication of papers and chapters. NEP provides a very wonderful platform for the students to gain knowledge , actively participate and contribute to interdisciplinary literature, science & research. This will help in hi higher education and will also remove the boundaries of certain career opportunities and employment
2. Academic bank of credits (ABC):	The academic bank of credit (ABC) as part of the National Education Policy 2020 gives opportunity to the students to for multiple entry and exit options. The State Government of West Bengal has formed a committee called 'State Academic Bank of Credit' to ensure proper understanding and implementation of the ABC of NEP 2020 in higher education in the atata. With implementation of NEP by the offiliating

state. With implementation of NEP by the affiliating university, , our college is strictly following the

	regulations of NEP 2020 including ABC. As per ABC, a student enrolled in UG/ PG course may exit the course after any level of award and may grab opportunities of employment and then again may get back to the course within a certain period of time for further completion of award when he finds the situation (that may be financial or other) suitable to pursue further education. This remarkable policy will ultimately reduce the number of college drop outs and will give the opportunity to full fill dreams of acquiring higher education for many children with socioeconomic restrains. Under ABC students will be allowed to gain credits from HIES registered under the scheme through SWYAM. Our Institute encourages faculties and students to enrol under various national schemes including MOOCS, SWAYAM, NPTEL etc.
3. Skill development:	NEP 2020 has included various skill oriented topics in the curriculum of different subjects. This will help to develop a huge number of skilled youth in the recent future that will not only open the doors of employment and opportunity for them but also will strengthen their outlook for entrepreneurship. The institute encourages and nurtures development of skill by arranging different workshops on various topics and by organizing cultural and sports competition from time to time. The NSS Unit of the college held workshops, outreach propgrames, health camps and social surveys in the adopted village that help to develop various types of general and special skills in the students. The new NEP syllabus has made it compulsory for each student to complete application oriented compulsory modules on Skill Enhancement. This will enrich them with the potentials of certain skills, analytical abilities and will help to develop their aptitude for handling problems. The college encourages and arranges events like debates, poster competitions, and competition etc., to further extent the concept of developing soft skills and life skills in the students besides basic education following the regulations of NEP 2020 as implemented by the affiliating university. Keeping in mind the diverse language and culture in our country, inclusion of knowledge system in NEP is an excellent decision that will positively enrich the students with the vast reserve of knowledge that is hidden in the Indian language and culture system. The college encourages implementation of Knowledge system (teaching in Indian Language, culture, using online course) under NEP 2020. The NSS Unit of the college arranges regular interactive outreach programmes in the adopted village where the volunteer students are encouraged to interact with the local people in their mother tongue Bengali and exchange thoughts and promote various type of awareness on health and social issues among the villagers. Subjects like Political Science, History, Philosophy etc., are offered in major courses. Also major courses are offered in languages like English and Bengali. The faculties of the Science departments of the college use Bengali along with English to explain the various concepts and aspects of science to the students. This feature of NEP not only builds confidence and instills pride of own culture and identity in students but also it will open new resources in front of them to explore and acquire knowledges and life skills. Focus on Outcome based education (OBE) is a

Focus on Outcome based education (OBE) is a feature included in the NEP 2020 that aims to assure fruitful outcome of the courses that a student pursues. The college encourages students to have all round development for successful outcomes. The institute continuously monitors the standards of education and follows OBE of NEP 2020 . following NEP 2020, The college offers scope to the students to make choice for subjects in order to ensure effective outcome. Some of the science departments conduct field visits, laboratory demonstrations and experiments that helps the students to gain deep insights and hands on skills into the subjects they

	learn. This covers OBE policy of the NEP 2020. OBE will help the students to get furnished with effective education, knowledge, skills and abilities that are necessary for pursuing higher education and for seeking employment after completion of the course. The college focuses on successful implementation of OBE in every sphere following NEP 2020.
6. Distance education/online education:	Distance education/online education will help lots of students to enrol for courses of his/her choice. Many students cannot pursue education because of various constrains. Distance education/online education will help to overcome such barriers and will make education available for many more. The institute has computers with internet facilities and smart class rooms and smart boards that can be utilized to impart online education to students. The college also encourages the students and faculties to pursue the distance and online education facilities available through SWAYAM and other online platforms offering academic courses. 'Digital Education' and 'Technology in education is one of the important components of NEP 2020. Faculties of the college take utmost care to educate the students digitally and to teach them with care handling computers and internet facilities. This helps the students to use avail distance and online education opportunities following the .guidelines of NEP2020.Interactive catering of knowledge to students using online platforms is in practice since the outbreak of the COVID outbreak. The Electoral Literacy Club (ELC) of the College has observed that most of the students above eighteen years of age are already enrolled as voters in the electoral roll. However, for the mere handful of students who are yet to be registered as voters, the ELC of the College takes active measures to spread awareness about the electoral process and get them acquainted to the various aspects of their civic duty of voting. Special lectures are arranged to inform the

new voters about their rights, duties, and the expected code of conduct at the time of polling. The students are also informed about the different methods of redressing grievances related to the electoral process. Efforts are made by the college to help these uninitiated voters to know about the various modalities and make them realize the importance of their contribution to the democratic process of election. They are urged to get themselves enlisted on the electoral roll as early as possible and get Voter's ID cards issued in their names.

Response:

The Institute always follows a combination of traditional and contemporary teaching strategies. By

following such methods, we have experienced that learning becomes more student-centred. Different student-centric learning strategies have been implemented to motivate the students beyond the realm of theoretical knowledge. The college provides all feasible assistance for the faculty members' use of student centric teaching, which includes techniques like the following:

- 1. Smart classroom.
- 2. Projectors and a smart board.
- 3. Faculty members' personal laptops.

Students' seminars are organized by various departments of our college. Students are encouraged to give seminar presentations regularly. Additionally, students get the chance to go on field trips / excursions, work in the field, visit museums, different extension activities to the adopted villages and local community. For teaching purposes, the teachers use ICT enabled tools for effective teaching-learning process. The teachers employ ICT-enabled technologies including projectors, desktop, laptop, printers, to deliver lessons. The institution also has a seminar room with ICT capabilities and two smart classrooms.

Particularly during the academic year 2020–21, classes could not be held as usual because of the COVID-19 pandemic situation. Teachers were strained to adopt online teaching approaches as a result of the sponsoring University's initiative. All of the college's faculty members attended online courses. All teachers committed their time to teaching for the online classes using a desktop, laptop, mobile phone, tablet, etc. Platforms including WhatsApp, Google Class Room, Zoom, were used for this. The students received study materials on a regular basis using this portal. The same procedure was used to administer tests to the class.

2.5.1

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

The institute follows a transparent and robust mechanism of Internal Assessment. In addition to exams taken according to the exam schedule prepared by the exam committee, internal assessments by different department are also carried out at the proper time. Internal assessment time tables and notices are distributed in the class posted on notice board and maintained in departmental record. Necessary attention to the whole procedure is maintained until the assignments are finished. The main objective of

conducting internal examination is to prepare the students for the upcoming university examinations. The departments arrange for continuous evaluation though only one external assessment per semester is mandatory under the university regulation. During the pandemic period of 2020-21 and 2021-22 (partly) the internal and external examination were taken on online mode. Question papers were shared through mail and answer scripts were submitted in the respective mails. Though evaluation of internal assessments is a continuous process yet the weakness of the students is discussed in the class and suggestions are given. So far, no grievance regarding the internal or external examination were reported by the students. There is student's grievance and Redressal Cell in the college, which regularly follows and resolves the grievance received from the students. A box under lock and key is installed in the college building with provision to drop letters. Face to face meetings, co-ordination meetings are carried out on a regular basis.

The college regularly makes an effort to monitor the progress of the students, regardless of whether they have made the decision to continue their education or have found employment. The grades or marks students got in the University exams serve as a gauge of the end outcomes of the courses or programmes. While course outcomes can be evaluated based on course results at the conclusion of a semester, the programmed outcome is generated from the programmed result if the student has successfully completed all six semesters. Teachers are encouraged to participate in faculty development programmes, orientation programmes, refresher courses etc. and get enriched keeping pace with the development of modern technologies so that they may utilize the same for catering knowledge to the students. Teachers are encouraged to acquire more knowledge and education and to go for their PhD

programmes preferably in part time mode. The institution provides an environment suitable for innovation and all round growth of faculties and students.

Students are provided with all necessary guidance for their learning process. 3.4.1

Response:

The significance of community services and extension activities is to ignite the spirit of social awareness and social responsibilities in a student's mind. It enables them to realize their responsibilities to do something significant for the society and to contribute to the development of the society they belong to. Various activities related to community services and development and the extension activities are carried out annually by the Unit 1 of National Service Scheme (NSS) of our college. Students are sensitized to social issues like healthcare, nature conservation, literacy, pollution, cleaning etc. One of the prime goals of NSS is to develop a connection between the students and their surrounding environment and community so that their all round development is ensured. The NSS volunteer students and the concerned teachers interact with the people of the adopted village and focus on understanding their problems ad aims at finding solution to those. NSS unit also suggests practical ways out of the existing problems of the adopted village if possible. This develops the spirit of team work among the students and is beneficial for addressing the problems faced by the local people.

The COVID-19 outbreak and the lockdown prevented visit to the adopted village in person by the NSS volunteers but online platform provided the opportunity to reach a large number of audience. Awareness programmes on precautionary and protective measures against COVID-19 were organized online. Counselling programmes were organized for students who were in mental distress. NSS volunteers extended special help during the vaccination pogrammes in the college. The Volunteers also spreaded awareness about the vaccination programme against SARS-CoV-2 in their locality. NSS volunteers were kept motivated and focused by involving them in regular online programmes organized by NSS unit of the college during the lockdown period. Following the re-opening of the college, the NSS volunteers actively participated in carrying our various regular NSS activities physically but maintaining the protective protocols against COVID-19. Gradually with reduction and control of the cases of COVID-19, the various NSS activities regained full swing. The enthusiasm, dedication, motivation and sincerity observed among the NSS volunteer students reflect success of the objectives of organizing the NSS activities. Man is a social being. Accepting and executing social responsibilities, providing selfless service to the commuty, protecting and preserving the environment are inevitable parts for assuring safe, sustainable existence of an individual on the earth. Government General Degree College at Kharagpur-II is a nine years old institution with very humble beginnings. The College has 11 undergraduate Departments. The college has a total strength of 27 extremely competent faculty members. Along with the traditional chalk-and-talk method of teaching, audio-visual aids goes hand-in-hand. This institute contains two smart classrooms. During the trying times of the pandemic, the total teaching-learning process was conducted via different online modes. Teachers also share e-books with the students. A big playground on the college campus motivates the students to be physically fit and makes them engage in more sports-related activities. The faculty of the college encourages students to remain fit. A moderately designed Gymnasium and Sports equipment are available for the students.

This college has 17 classrooms along with a spacious conference hall and a seminar hall. For the students' recreation, the college provides two common rooms of which one is a separate common room for girls.

The campus is helpful for the differently-abled, as it contains handrails, toilets and a ramp at the main entrance.

The college marks a space and a first-aid facility is available for medically sick persons. It has separate toilets for male and female students and faculties. This college has zero tolerance for ragging and sexual harassment and as a result, it has separate cells addressing these issues (when and if required). The college encourages students to be better in their co-curricular activities along with their academic interests.

Teaching – learning and ICT – enabled facilities

Some of the rooms of college are endowed with fixed projectors for ICT enabled teaching learning practices. Many departments are also endowed with portable projectors which are regularly used for conducting classes in different classrooms.

The Departments of Physics, Chemistry, Physiology, Zoology, Botany, and Mathematics have their own laboratories with state of the art equipments and elaborate specimen collections.

The Department of Chemistry has 1 Organic Chemistry Laboratory, 1 Inorganic Chemistry Laboratory, 1 Physical Chemistry Laboratory and 1 Instruments room.

The Department of Physiology has a Laboratory where human experimental, biochemistry and Histology works go on.

The Department of Botany has a Microbiology Laboratory and a laboratory cum classrooms.

The Department of Zoology has a wet laboratory and a dry laboratory.

The Department of Mathematics has a laboratory cum classroom where C programming and C++ works go on.

Facilities for Cultural and sports activities, yoga centre, games (indoor and outdoor),Gymnasium, auditorium etc

Government General Degree College at Kharagpur 2, is a government college under the Higher Education Department, Government of West Bengal. The employees of the institution are entitled to all the welfare schemes that are specially allocated for the bonafide government employees. The West Bengal Health Scheme (WBHS) covers all the teaching staff and only permanent non-teaching staff. WBHS is maintained by the Medical Cell under the finance department, Govt. of West Bengal in consultation with the Health and Family Welfare Department (See G.O. No. 3472-F dated 11.05.2009). The WBHS caters the employees with an insurance policy for medical treatment. This ensures that they can get medical treatment from Government Hospitals, Nursing Homes and Medical Institutions including low-cost medical diagnosis from WBHS-empanelled diagnostic centres. There are two types of facilities – Cashless and reimbursement. Our employees can avail cashless IPD treatment in a private empanelled hospital up to the limit of Rs. 1,50,000/- (See G.O. No. 73-F(MED)WB dated 28.04.2022). In cases where the treatment costs above Rs. 1,50,000/-, the employee can apply for reimbursement through the online WBHS portal. The dependent family members are also provided medical insurance and they are incorporated as beneficiaries in the WBHS. It also has the provision to obtain medical treatment outside the state as per their need.

The institution has a performance appraisal system for teaching staff. All the teaching faculties are required to fill self-appraisal on a regular basis. The teaching staff are required to write correctly the arrival and departure time, mention the allotted and number of classes taken and briefly state any academic or administrative activities performed during duty hours. This also maintains a record of the number of Casual, Earned and Duty leaves they have taken throughout the month.

The Government has introduced Self Appraisal Report (SAR) for the teaching faculties which is to be filled in through WBIFMS. The Self Appraisal Report is made on the basis of the performance and committee membership of each teaching faculty under the institution. This SAR system is a hierarchical system where the self-appraisal report has been passed through the Reporting officer, the Reviewing officer and the Accepting Authority. The non-teaching staffs need to submit their appraisal to the higher authorities during their confirmation and promotion. The student feedback system is maintained and followed in a regular manner to ensure that quality is maintained in the teaching practices adopted by the institution.

Students are familiarized with the need for filling up feedback forms and every department evaluate the teachers' activities and teaching-learning methods from their own points of view. The highly motivated members of the teaching faculty of our institution are continuously adopting new teaching methods and updating the same based on such evaluations.

The teachers get chance to participate in Orientation Program, Faculty Induction Program, Refreshers Courses, Short Term Courses and Workshop to enrich themselves.

6.4 Financial Management and Resource Mobilization

6.4.1

Institution has strategies for mobilization and optimal utilization of resources and funds from various sources (government/ nongovernment organizations) and it conducts financial audits regularly (internal and external)

Response:

The Government General Degree College at Kharagpur-II is completely funded and controlled by the Higher Education Department, Government of West Bengal where the Institution has to submit a proposed annual budget every year for the salaries and other related heads. For the purchase of any kind of equipment, glass goods, chemicals, books and other contingent items the Institution has to place demand to the Higher Education Department, Government of West Bengal. The Government authorities sanction the amounts for salary and for other infrastructural and developmental purposes in a centrally controlled HRMS system that has IFMS for financial management. This institution has a Purchase Committee which floats tenders (paper or e-tender) according to the existing laws of the Government of West Bengal. After floating tenders, the committee compares the quotations. Then the Institution ordered the items in consultation with the Head of the departments to recognize vendors through proper channels. After receiving the items it has to be inserted in the departmental stock registers and submit the bills to the College office for e-payment through IFMS. Generally the Institution utilizes all the sanctioned amounts and submits utilization certificates at the end of the financial year to the Government of West Bengal.

Being a Government Institution, the accounts of this institution are liable to be audited through proper channels. Apart from that, the Institution used to conduct internal audits regularly. This institution recently conducted an external audit from a renowned chartered firm. The audit reports are enclosed herewith.

The college ensures that students are trained to respect all genders, support inclusion and sustainable development. The college remains committed to educating, engaging, and instilling the right values among students for furthering national developmental goals. The college's gender policy delineates a set of standards and principles implemented by the institution to guarantee a secure, comprehensive, and fair atmosphere for all individuals, irrespective of their gender identity or expression. Government General Degree College at Kharagpur-II : A brief profile with respect to gender Our institution is committed to equity, equality and quality education for all students irrespective of their gender, race and ethnicity, economic background, caste and creed and sexual orientation. The college is a zero tolerance zone for any kind of sexual harassment. The college has consistently encouraged the admission of female students. Consequently, the institution boasts of a healthy gender ratio within each classroom. It is seen that over 50% of the students are female which is self-explanatory. The Cultural Committee and Students Welfare Committee organize various events throughout the year to sensitize students on gender related issues. These include talks and seminars, awareness camps, movie screenings, workshops and cultural programmes. Sanitary pad vending and disposal machines are installed in the female faculty washroom. Students can raise any complaint of harassment to the Internal Complaints Committee, who deals with each case with utmost confidentiality. The college has a Women's Cell devoted specifically for the development of women. Gender Audit Surveys are regularly conducted by the Women's Cell and relevant actions are taken on the basis of suggestions and recommendations. The college has a Student Grievance Redressal Committee as per UGC Regulations, 2019. Creating awareness on gender issues. The college offers several papers as part of the CBCS curriculum as part of challenging the ageold stereotypes of gender and also to facilitate developing awareness about the struggles that women have historically faced and the resistance that they have heroically offered to forces of patriarchal subjugation and religious tyranny. 7.2 Best Practices

7.2.1

Describe two best practices successfully implemented by the Institution as per NAAC format provided in the Manual

Response:

1. Career enrichment beyond classroom: Campus Bazar

Objective: To motivate our students to taste the challenges of self-financing, entrepreneurship and to create opportunity for them to toy with the idea of startups as career prospects.

Context: In this rural college, most of the students hail from agricultural backgrounds. They already have some knowledge of different types of plants, seeds and fertilizers. Some female students are good at making simple household items, accessories for personal use, food items like snacks, jam and pickles. During their interaction with the faculty members, the students have shown interest in monetizing their hobbies, like gardening, handicrafts and cooking. The institution has noted this interest and given them a platform to showcase and sell their handmade efforts.

Practice: Campus Bazar is organized in the college premises by the Placement and Career Counselling Cell. Temporary stalls are put up for the students to sell flowering plants like rose and hibiscus, exotic seeds, houseplants, medicinal plants and nursery items. Students display handmade bangles, earrings, necklaces, chokers, made with biodegradable and recycled materials. Students bring fried items and chaats to sell at the campus bazar. All the participants invest a little amount and take back home some profit as well.

Evidence of success: Motivated by the success of this initiative taken by the institution, some of our students who have passed out, are now engaged in making and selling handmade accessories, some are considering startups in near future. Palash Routh, Shilpa Maji, Sushanta Mishra, Soumen Maity have already started their own catering startup, inspired by the campus bazar.

Remarks: Campus Bazar initiative of the institution has also pushed the motto of Make in India and spread it successfully among the participants.

2. Social Involvement Programme: Diet Surveys

Objective: The Department of Physiology carries out diet surveys to ascertain nutritional and health status of the people in the local communities.

Context: These surveys are an integral part of the community based studies under the Physiology Honors and General courses of undergraduate programmes of Vidyasagar University.

Practice: The students carry out these surveys either in their own families or other families in their immediate neighborhood. They evaluate the excess intake or deficiencies of calories, macronutrients like carbohydrates and proteins as well as micronutrients like iron and calcium. They preferably adopt weighment of raw food methods to conduct these studies. The participants are advised to reduce or increase dietary consumption of the nutrients depending on the findings of these studies. The daily intake observed is compared to the recommended dietary allowances of the nutrients as laid down by the ICMR upon recommendations from NIN of India.

Evidence of success: Till date, the families with obesity cases, anemic members, have benefited a lot from the recommendations after the completion of these surveys. Excess calorie intake or iron deficiency in diets were confirmed through these assessments. Thus, the people participating in the studies were made aware of their imbalanced dietary habits at an early stage where they could take early initiatives like restricting carbohydrates, etc.to control body mass index or BMI and in turn avoid obesity induced

insulin resistance (diabetes) or hypercholesterolemia.

Remarks: Local communities are reached out through these programmes and a healthy community may be ensured as a positive outcome of such surveys.

7.3 Institutional Distinctiveness

7.3.1

Response:

Priority: Spreading higher education, Ensuring quality education for local students aspiring for higher education, Bridging the gender gap by implementing equity and equality for all, irrespective of their caste, class and creed.

Overview- Our institution has been set up by the Government of W.B only in 2015 with an objective to bring to the students of this rural block the opportunity for acquiring employability by receiving quality education and a B.A/B.Sc degree that will help them in the highly competitive job market waiting for the educated young brigade fresh out of college. The ultimate objective of most of the students of this institution is to be financially independent. Therefore, it becomes the duty of the institution to provide a platform to develop and polish their skills and expertise and prepare them for the workplace. GGDC at Kharagpur-II is fully committed to molding the students as confident and self-reliant individuals with good command over soft skills.

The Process- The institution has undertaken the following methods to fulfil this objective:

- 1. The *guru-shishya parampara* is a landmark of the Indian knowledge system. The bond between the teacher and the student has always been held in the highest esteem in our culture. The National Education Policy of 2020, theoretically speaking, is an attempt at reviving the traditional with a progressive openness. Our college nurtures a healthy teacher-student relationship which is very much required in today's times that often witness the deterioration of the sacred bond.
- 2. Attendance College motivates its students to maintain above 75% attendance by giving them marks for class attendance in the internal assessment examinations, as prescribed by Vidyasagar University. Students are required to maintain 75% positively. Their attendance is regularly displayed at the departmental notice board.
- 3. Our institution boasts of a healthy teacher-student ratio which ensures smooth and effective dissemination of knowledge and information. That our pupils can communicate with their professors freely and without any inhibition, awkwardness or insecurity has contributed to the

student-friendly environment.

- 4. The teachers of this institution always go the extra mile to ensure that the students enjoy an easygoing atmosphere within the boundaries of the institution. Some of the students are first generation learners who get all sorts of academic support both inside and outside of their classrooms. The professors are generally accessible over phone and emails during vacations.
- 5. Assignment- Subject teachers give the students projects and assignments based on concepts to develop their subject specific skills. They need to submit at least 1 assignment per paper in each semester.
- 6. Participation in Intercollegiate Competitions- Students participate in various national and state level competitions which provide them with exposure and opportunity to assess their potential.
- 7. Collaboration with other colleges- MOUs have been signed with nearby colleges. Student and Faculty Exchange programmes have been undertaken to increase interaction and participation, thereby creating an ecosystem conducive for learning.

8. Student counseling- Faculty mentors are assigned a number of students to counsel. The objective is to encourage and guide them. The college has also appointed a professional for the psychological counseling of the students since 2022.

9. Tutorial classes for students- Tutorials are conducted every week. Slow learners are identified in every subject on the basis of marks obtained in internal exams. They are especially looked after during the tutorial classes.

10. Talent Hunt through cultural programmes- These are organized frequently and students are encouraged to take part in them and showcase their talents.

11. Participation in College Sports- Annual Sports Meet is organized by the Sports subcommittee every year. Female students are particularly encouraged to take part in various events to inculcate in them the motivation for physical fitness. Students learn sportsman ethics and the need for healthy competitive spirit.

12. Personality development classes- Soft skill classes are part of curriculum to enhance

the personality as well communication skills of the pupils, with an eye to their future employability.

13. Seminars/ Guest lectures / Alumni lectures- They are conducted every semester to develop the interest of the students in career opportunities and higher education. An expert talk is arranged every year during the Students Week to give the students a glimpse of the career options they have after completing their graduation from this institution.

14. Research and development- In the last five years, the Institute has collectively produced more than 50 original research publications in journals of national and international repute. The faculty members have also published many books and book-chapters.

Evidence of Success:

Teachers of this college know their students by name so that the students can feel the warmth emanating from their teachers who, as a result, never shy away from interacting with them in order to give them the support they need in order to impart effective instructions.

• This college offers Undergraduate degrees. Many of our students choose to pursue higher studies despite their socio-cultural challenges. This indicates the institution's success in the spreading of interest in academics.

• Percentage of students placed in different private and public sector jobs is rising if we consider the fact that the college has only been established in the academic year 2015-16.

• Higher Education- Students are selected for prestigious institutions like Calcutta University for Masters in English, Bankura University for PhD in Bengali.

• Students have qualified various state/national/ international level examinations during the last five years. It includes GATE/NET/SET etc.

Students have received awards for outstanding performance in sports and cultural activities at university, state and national during the last five years.

Students have been involved in startups. To encourage them to start their own financial ventures, a campus bazar has been organized where the students display their handicrafts. Both students and faculty members came together in support of the event that gave the students a taste of selling their own handmade items and enjoying the whole process. Some female students are making and dealing in handmade accessories. They also take part in exhibition-cum-sale events. Students hailing from agricultural families are also engaged in small-scale businesses of plants and seeds.
